CONSENT FORM (Media / Photographic / Video / Audio / Communication Release)

What is this consent form for? ...The consent form, when completed and signed by the student and, the student's parent or guardian, will authorise Holy Spirit School and Brisbane Catholic Education to use any photographs, video footage or sound recording of the student in school and/or Brisbane Catholic Education publications, productions, presentations or media. This includes electronic media such as the internet.

Who should sign the consent form? ...The student (where appropriate) and/or the student's parent/guardian or carer. While Holy Spirit School and Brisbane Catholic Education will make all reasonable efforts to ensure that only appropriately authorised persons complete the consent form and sign the authorisation in section 4, Holy Spirit School and Brisbane Catholic Education will not be responsible for circumstances in which it is misled as to the identity and authority of that person.

What happens to the consent form once it is filled out and signed? ...The consent form will be placed on the student's file or record and retained by the school. If requested, a photocopy of the form will be made available to the student and/or the student's parent or guardian.

- Access to Holy Spirit School and Brisbane Catholic Education staff and use of school and Brisbane Catholic Education facilities will be entirely at the discretion of the school and Brisbane Catholic Education; and
- Media access will be managed, where possible, by the principal and/or representatives of Brisbane Catholic Education.
